OCEC Waives Monthly Fee in December

This one month waiver will reduce year-end margins.

Okanogan County Electric Cooperative (OCEC) has waived the monthly base fee on its members' accounts for the December 2018 billing period. This will be reflected on the bill received in January. For most customers, this will reduce the monthly power bill for this one month by either \$32 or \$50 depending on which rate you are on. Irrigation accounts will receive a credit on their bills at the start of the irrigation season.

After review of projected year end margins, the OCEC Board determined that this waiver was appropriate given the projected year-end margins for the year. OCEC is a non-profit cooperative and is owned by its members. All margins (revenues less expenses) are eventually returned to members and this is one way of doing this.

OCEC General Manager David Gottula said "A combination of lower expenses along with higher than expected revenues in 2018 has produced higher margins than forecasted and this one-month waiver of the base fee is a way to lower the existing member's bills and reduce our margins. Also with December being a high usage month and our members potentially having high power bills, every little bit we can reduce power bills helps our members." OCEC also recently announced that there will be no rate increase in 2019.

OCEC Board Makes Selection to Fill Empty Board Seat

The OCEC Board of Directors has selected Michael Murray as the replacement for Chuck Armstrong who resigned from the OCEC Board in October. Mr. Murray will need to run for election for this position in April.

BPA Energy Efficiency Funds Exhausted

Many OCEC members with commercial buildings took advantage of BPA's energy efficiency program, changing out their old lighting for more efficient LED lighting. Because of this, OCEC has used up its allotted funds and has put a moratorium on the program. Funds from other cooperatives may be available to us near the end of summer 2019, but until then the program is on hold. Starting in October 2019 (BPA's new fiscal year) our energy efficiency funding will be replenished. OCEC would like to thank all the members who participated in this program.
