### Call for Candidates by February 24 for OCEC Board Election

The OCEC Annual Meeting and election by members of the Board of Directors will be held this year on April 20th. The members will be electing three Directors for a three-year term and one Director to complete the remainder of a two-year term.

Per the OCEC Bylaws, the Board appointed "Nominating Committee shall nominate at least one (1) Member for each position open for election. The incumbent shall automatically be one of the Director candidates nominated if that Director desires to run for re-election." Two incumbents are planning to run for re-election for the three-year term (one Director is not running for re-election) and one appointed director is planning to run for election to complete the remaining two-year term.

It is desirable for OCEC members to have choices for consideration for the Director positions. If you are interested in running for election for either the three-year term or the two-year term, you are encouraged by the Board to submit your name to one of the members of the OCEC Nominating Committee for inclusion on the ballot.
