Okanogan County Energy Names New Propane Operations Manager

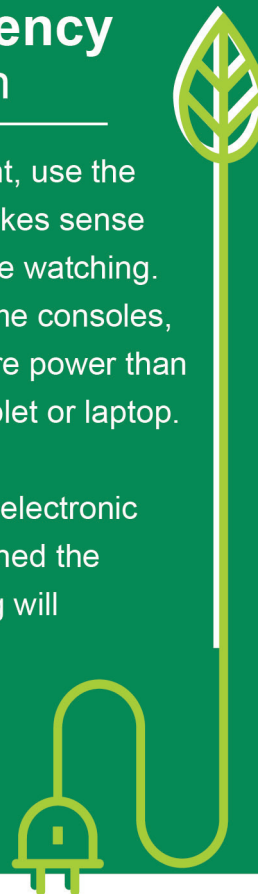
