## **OCEC Moves Forward with Grant Application**

Okanogan County Electric Coop (OCEC) has advanced in a federal grant application under the umbrella partnership of the National Rural Electric Cooperative Association (NRECA) to help fund rural utility projects that will decrease wildfires caused by utility equipment and strengthen electrical grid systems in wildfire prone areas. The OCEC project concept is to relocate and replace an overhead primary power line with underground equipment in the Rendezvous area. The new route would allow accessibility throughout the year, improve reliability for consumers and reduce the risk of wildfire in a state protected area. We will keep our members updated as the process continues.

### OCEC RATE INCREASE EFFECTIVE APRIL 2023

With the recently approved 2023 budget by the OCEC Board, members will see a rate increase

beginning in April 2023. The increase will be approximately 5% for all rate classifications and will show up on the May 2023 billing statements. One primary driver for this needed increase is the rising cost of wholesale power above our Bonneville Power allocation for our growing system. The additional power purchased above that allocation has increased by nearly 100%. Also, OCEC has experienced significant cost increases for necessary specialized equipment to maintain a reliable and resilient electric distribution system. Certain materials have increased over 200% in an 18-month period. OCEC has not had a rate increase since 2018 and we will always strive to keep rates affordable.

#### How will the rate increase affect my monthly bill?
